Council Member Rene Duran made the second motion. The motion passed unanimously.

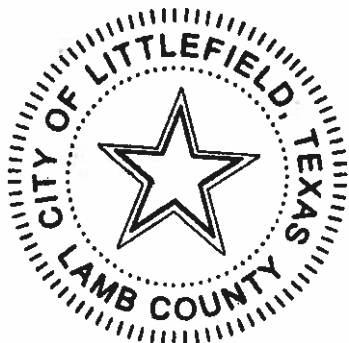
